5. Comments on behalf of Cowbridge with Llanblethian Town Council regarding proposals at the Former Cowbridge Comprehensive School:

- Strongly and unanimously object to the proposal.
- The height and location will be an eyesore for existing nearby residential areas.
- Will not be able to accommodate adequate parking for those living there.
- Residents will have difficulty walking to the village, and the Aberthin Road is very dangerous.
- Residents will be unable to open windows due to pollution from the bypass.
- It's an over development for the number of flats and houses proposed in a small area. Also, the Local Development Plan outlined 20 units. This proposal is for 34 dwellings.
- Unattractive development that does not propose to keep the facade of this historic 1896 girls' school.
- Insulting to say the existing building has little aesthetic quality. It is a Victorian, Gothic late Queen Anne style building.
- Will cause major traffic issues, especially during school opening and closing hours.
- The loss of Yew Trees from the site.
