## Item 6: To consider estimate for work on Cremation Wall at the Limes Cemetery

Members were reminded that it had been a resolution of the Council that a project for a cremation wall to be installed in the Limes Cemetery had been ratified by the Town Council.

The Clerk had been instructed to investigate costs in relation to the building of a cremation wall and report back to the Leisure and Amenities Committee. It had been previously agreed that the installation of the memorial wall should be completed as near to the end of March 2020 as possible as it had been incorporated in the 2019/20 financial budget.

Members were provided with an estimate quotation for the wall. Members were also provided with information on alternative cremation trees and monolith. It was agreed that the quotation for the wall was not within budget and did not meet with the Council's requirements.

Following discussion it was agreed that the Clerk should find out which cemeteries the the cremation trees are installed in and advised the committee members so that they have them opportunity to see them in situ.

Cllr Baty thanked the Clerk for researching this matter and bringing additional information for the Committee to consider.
