Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement has been prepared in accordance with proper practice and whether it properly presents the Council's receipts and payments and financial position for the year:

- The Council has not provided the information required for me to complete my audit regarding staff costs and creditors.
- The Council has not kept adequate accounting records to support the reported income & expenditure and financial position for the year.
- The Council has not recorded any fixed assets within the annual return but has provided an asset register with assets totalling £433,292.67

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year:

- Assertion 8 – response to audit recommendations. The Council's internal auditor has raised a number of issues regarding the Council's fixed assets. The Council has not implemented the recommendations raised. It is recommended that the Council implements all recommendations raised by internal and external audit.
